121/2016 MATTERS ARISING

Fly tipping in St James Close car park – PC to approach MK council with regard to enforcement being taken. It is believed the problem is being caused by one resident who has previously been approached regarding this situation.

122/2016 ACTIONS FROM THE OPEN MEETING APRIL 11TH 2016

- **Bus shelters** a tender of works to be issued to repair/refurbish the bus shelters in Castlethorpe Rd, Market Square and at the entrance to Williams Close. Contract will be awarded at July meeting. (MP)
- Village map and information boards the Historical Society will be approached to consider which aspects of the village the proposed information boards should highlight, number and location. (SM)
- **Post Boxes** the Royal Mail will be approached to discuss refurbishing the existing boxes (EP)
- Litter bins the Clerk will be instructed to place an order for the type and number of new bins in accordance with decisions taken at previous PC meetings. (Clerk)
- Extension of footpaths on the Recreation Ground to be considered as part of the overall works to refurbish the Pavilion in particular connecting the path at the front of the Pavilion with the play area, St James Close and Castlethorpe Rd, similar to the existing path from the car park to the all-weather courts. - Water mains leak near allotments the Village caretaker will be instructed to investigate the problem. (Clerk)

123/2016 CORRESPONDENCE / COMMUNICATION

Email: Condition of speed humps – suggested installation of rubber ones (similar to the ones in Castlethorpe).

Cllrs agreed to keep the matter under review and raise it with MK Highways when appropriate. It was considered that given the current budgetary restrictions at MKC it was unlikely to progress unless the existing speed humps showed signs of significant disrepair.

Dogs on the allotment – it was agreed that the Allotment Sub Committee would look into dog nuisance arising it was believed from dogs belonging to the users of the horse paddock and stables next to the allotments. (MP)

Bonfires on the allotments – it was agreed that warning notices would be put up on the allotment notice board reminding allotment holders of their responsibilities to negate the nuisance value of such bonfires to local residents under Rule 28 of the Allotment Rules and Regulations. Further action will be considered if this proves ineffective.
