## **Item 3 Matters Arising Items 1-6**

DC reminded RL that the Free Dog Bags previously promised to the NAG had not yet been delivered. RL to honour this request but he also stated that this would be the very last issue, as MKC could no longer afford to fund this. If, however, Parish Councils wish to continue with such an initiative, RL can supply name and charges of MKC supplier to Parish Clerks.

RL informed group re: cost of purchasing and installing dog bins in appropriate positions within the three parishes. Seven bins have been requested at a purchase cost of £350, with installation at £230. Decision to go ahead with purchase proposed and seconded. PA requested that this be done by 12<sup>th</sup> April if possible. Same contractor to empty all the bins throughout the RW. NAG. RL to liaise with Sarah Neal re: filling in of Application For Funding Form.

R.L gave small presentation re other items available connected with "dog-fouling" issues.

R.L also suggested that after bins had been installed, a member of his team would be available to visit the three parishes with a stall promoting various methods of dealing with the dog-fouling problem.

D.C. presented an R.W. NAG Contact List to all members. This was corrected/ amended where necessary. Hopefully members will now be able to liaise more easily.
